**How do I decide what to give?** First, pray for guidance and direction on making your pledge. Listen for that guidance. If you are making this commitment as a family sit down and talk about your finances, your family goals and values, and Trinity Lutheran Church's ministry. Give with joy and thanksgiving.

**What if my financial circumstances change during the three-years?** Remember, a pledge is what you plan at this moment to give toward this Capital Campaign. If your financial circumstances change you may change your pledge either by decreasing it or increasing it at anytime.

**Can I set up automatic withdrawal from my checking or savings account?** Yes, simply mark that choice on the form and Julie Schaffner will contact you.

**Use this chart to help you think about your gift:**

\$20,000 gift means about \$6,700 yearly for the three years of the pledge or about \$560 monthly.

\$10,000 gift means about \$3,350 yearly for the three years of the pledge or about \$280 monthly.

\$5,000 gift means about \$1,670 yearly for the three years of the pledge or about \$140 monthly.

\$4,000 gift means about \$1,335 yearly for the three years of the pledge or about \$112 monthly.

\$3,000 gift means about \$1,000 yearly for the three years of the pledge or about \$85 monthly.

\$2,500 gift means about \$835 yearly for the three years of the pledge or about \$70 monthly.

\$1,500 gift means \$500 yearly for the three years of the pledge or about \$42 monthly.

Examples provided are simply that; gifts may be made in any amount. You may also make a one-time gift.
